

Money in Your Pocket – It's Yours!

You've paid taxes into the system. But you can also get money back, if you're eligible. You can get up to \$4,300 from the federal Earned Income Tax Credit or up to \$982 (or more) from the state TAX BACK.



It's your money. A family of four earning up to \$35,500 can qualify. Apply for it when you file your taxes.

When you file your 2004 taxes, just file these additional forms:

- Schedule EIC with your federal tax return.
- PA-40 Schedule SP with your state tax return.

Get More for Your Money!

FREE help filing tax returns is available for low-income families. When the help is free, *you keep all of your money.* Call the certified tax help office in your county, listed on the back.
